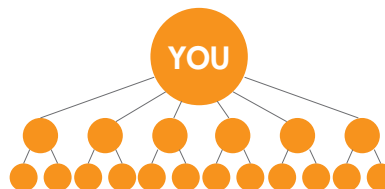

COMPLETE INCENTIVE CRUISE RULES:

1. Incentive cruise qualifying period runs August 1, 2015 through March 31, 2016.
2. Incentive cruise is open to all active LifePharm Independent Business Owners who are in good standing with LifePharm and are up to date with the annual IBO renewal fee payment.
3. New personally sponsored team members between July 1 - July 31, 2015 will count toward personal sponsorship requirement.
4. Incentive cruise winners will be notified by email by April 10, 2016.

INCENTIVE CRUISE QUALIFICATIONS:

1. Personally enroll 12 new first level Independent Business Owners or personally enroll 6 new Independent Business Owners on your first level and 12 on your second level. New enrollees must achieve at least 100 cumulative QV within the incentive period.
2. Maintain personal volume of 90 QV during each month of the promotion period.
3. Reach and maintain 30,000 QV for at least two months during the six-month qualification period for double occupancy or reach and maintain 15,000 QV for at least two months for single occupancy ticket. No more than 40% of 30,000 QV/15,000 QV may come from one leg.
4. IBOs earning the incentive trip must RSVP for the cruise and provide all necessary travel documentation for themselves and their guest no later than April 15, 2016 in order to attend the trip and have their cabin reserved and space held.

LIFEPHARM WILL PROVIDE THE FOLLOWING:

1. Ticket to next LiFEvention event.
2. Two \$500 travel stipends for double occupancy ticket earners or one \$500 travel stipend for single occupancy ticket earners deposited into your eWallet once you RSVP for the cruise incentive and provide documentation for travel to departing port of call.
3. Double occupancy cabin for LifePharm IBO and his/her non-IBO guest over 18 years of age. If guest is a spouse and LifePharm IBO, he/she may attend the trip. Cruise cabin rooms are based on double-occupancy. LifePharm will make every effort to pair single IBO travelers with other single travelers. If room is not filled, single IBO may be responsible for paying the room price difference.
4. All meals for cruise travel, port fees and travel taxes are included in the cost of the double or single occupancy cabin and will not need to be paid for by the qualifying LifePharm IBO.
5. All excursions, beverages and additional services IBO books or requests while on the ship or at a port of call will be at the qualifying IBO's expense.
6. All ground transportation, baggage fees and gratuities to and from the cruise departure/arrival destination in Barcelona, Spain are at the qualifying IBO's expense.

ADDITIONAL INFORMATION:

1. Cruise and LiFEvention ticket will be considered as taxable income and be noted as such for 2016.
2. No cashout is available for this incentive. If cruise is earned but not claimed, IBO forfeits prize package. Cruise trip is non-transferable.
